After the Vendor has paid the Rebate amount, if no ad valorem stamp duty calculated at New AVD Rates is payable or if the amount of the stamp duty actually payable is lower than the estimated stamp duty amount on which the Rebate is calculated by reason of the Stamp Duty (Amendment) Bill 2013 being amended or withdrawn or otherwise, the Purchaser has to refund the Rebate or (as the case maybe) the excess of the Rebate paid by the Vendor forthwith to the Vendor. If the amount of the stamp duty actually payable is higher than the estimated stamp duty amount on which the Rebate is calculated, the Vendor is not required to pay any other or additional Rebate to the Purchaser.

In any other cases, the purchaser shall bear his own solicitors' legal costs and disbursements in respect of the purchase of the residential property.
